

MSF/GSMA VoLTE INTEROPERABILITY EVENT 2011 CONTRACT

The MultiService Forum (MSF) and GSM Association (GSMA) are sponsoring a VoLTE interoperability event focusing on validating core network interfaces to ensure multi-vendor deployment strategies for LTE technology and will validate the MSF Physical Scenarios developed to incorporate 3GPP LTE/SAE technology and GSMA technical recommendations with the support of China Mobile and Vodafone.

The main Physical Scenarios that will be tested are:

- Basic Interoperability:
 - Basic Configuration – Voice over LTE compliant to GSMA PRD IR.92.
 - MME Pooling.
- Roaming and Interconnect:
 - VoLTE Roaming with Local Breakout – Visited P-CSCF with Home routed IMS traffic compliant to GSMA PRD's IR.88 and IR.92.
 - VoLTE Interconnect – between two PLMN's compliant to GSMA PRD's IR.65 and IR.92.
- Non-LTE Access to EPC:
 - UTRAN/GERAN UE access via S4-SGSN into EPC.
 - UTRAN/GERAN UE access via legacy SGSN.
- Handover/Relocation:
 - between eNodeB's
 - between MME's
 - SGW Relocation
 - between E-UTRAN and UTRAN/GERAN utilising S4-SGSN to MME
 - between E-UTRAN and UTRAN/GERAN utilising legacy SGSN to MME
- Self Organising Networks/Automatic Neighbour Relation

Contracts and Payments

The participation fee is paid on a per company basis with no additional cost to participate at multiple sites. 50% of the fee must be received no later than **May 31 2011**. The balance of the fee must be received no later than **July 29 2011**. Payment of the participation fee may be made via check in US currency (payable to the MultiService Forum), credit card (Visa, MasterCard, American Express), or wire transfer.

The Operator observation fee per site is waived for MSF Members, \$1000 for GSMA Members and \$12,500 for non-members. 50% of the fee must be received no later than **May 31 2011**. The balance of the fee must be received no later than **July 29 2011**. Payment of the Operator observation fee may be made via check in US currency (payable to the MultiService Forum), credit card (Visa, MasterCard, American Express), or wire transfer.

Please note: After **July 29 2011** at the sole discretion of the MSF and GSMA, the Participants who have not submitted a signed contract, NDA and payment-in-full shall be dropped from participation in the IOT Event.

MSF and GSMA reserve the right to reject any information content which MSF and GSMA find, in its sole discretion, to be objectionable.

Participant may promote the VoLTE event on their website including a link to the MSF website and the GSMA website, provided that any content or materials that include any MSF trademark or GSMA trademark must be approved in writing by MSF or GSMA respectively, prior to publication on Participant's website. MSF and GSMA hereby grants to Participant a non-exclusive, limited license to use the MSF trademark and GSMA trademark respectively, during the term of this agreement solely in connection with Participant's promotion of VoLTE event on Participant's website. Such use shall be in accordance with applicable trademark law, MSF's trademark guidelines, and GSMA's trademark guidelines as revised from time to time. Participant agrees that any such use shall inure solely to the benefit of MSF and GSMA, and that Participant shall not obtain any right in the MSF trademark or GSMA trademark beyond the rights expressly granted pursuant to this agreement. MSF and GSMA reserve the right to cancel the IOT Event no later than **July 15, 2011** based upon lack of sufficient Participant interest or other factors that in MSF's and GSMA's judgment make it not feasible to present the IOT Event. In such event, MSF and GSMA agree to give prompt notification to Participant and return fees paid by the Participant subject to the provisions set forth below no later than sixty (60) days following the date of cancellation.

If a participant does not meet the technical and contractual conditions for the event, the Technical Coordinator can recommend that the VoLTE Event team exclude the participant from the event. In the event of such exclusion the participant will not be entitled to a refund.

3. No Endorsement; No Sale

Participant acknowledges and agrees that Participant's participation in the IOT Event shall in no way imply or be an endorsement of the Participant's products, applications or services by MSF, GSMA or the IOT Event. Participant agrees that neither it nor any of its employees or representatives may make any statements to the effect that MSF or GSMA endorse or has selected any products, applications or services.

Participant shall not sell or offer any products or services during the IOT Event.

Participant shall refrain from making any comments disparaging MSF, GSMA or any participant in the IOT Event, or otherwise encouraging others to disparage MSF, GSMA or any other participant in the IOT Event, or taking any action designed to harm the public perception of MSF, GSMA or any other participant in the IOT Event, or such parties' products and/or services.

4. TERMS AND CONDITIONS

The IOT Event is intended to present cooperative, multi-vendor solutions related to the MSF/GSMA VoLTE Physical Scenarios by demonstrating the practical deployment of LTE technology.

The parties agree that the confidentiality provisions of the combined MSF/GSMA Non Disclosure Agreement (NDA) dated **May 31 2011** shall also govern this agreement.

MSF or GSMA may in its discretion supply funds, equipment or services for use during the IOT Event. All funds will be utilized in MSF's or GSMA's discretion to develop and promote the IOT Event according to the consensus of MSF, GSMA and the IOT Event Participants, and to compensate the MSF and GSMA for its services.

4.1 Disclaimer of Warranties

THE IOT EVENT AND ANY OTHER SERVICES PROVIDED UNDER THIS AGREEMENT ARE PROVIDED "AS IS." THE MSF AND GSMA DO NOT HAVE ANY CONTROL OVER THE IOT EVENT; ACCORDINGLY, THE MSF AND GSMA DO NOT MAKE, AND HEREBY DISCLAIM, ON BEHALF OF THEMSELVES AND THEIR SUPPLIERS, AGENTS, AND SUBCONTRACTORS, ANY AND ALL REPRESENTATIONS OR EXPRESS OR IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION, THE WARRANTIES OF NON-INFRINGEMENT, MERCHANTABILITY, AND FITNESS FOR A PARTICULAR PURPOSE.

4.2 Indemnity

THE PARTICIPANT SHALL INDEMNIFY, DEFEND, PROTECT, AND HOLD HARMLESS, THE MSF, GSMA AND THEIR RESPECTIVE OFFICERS, DIRECTORS, AGENTS, MEMBERS OR OTHER REPRESENTATIVES FROM ANY AND ALL CLAIMS, DEMANDS, SUITS, LIABILITY, DAMAGES, LOSSES, COSTS, ATTORNEY'S FEES, AND EXPENSES OF ANY KIND WHICH MIGHT RESULT OR ARISE FROM ANY ACTION OR FAILURE TO ACT ON THE PART OF THE PARTICIPANT OR ITS OFFICERS, AGENTS, EMPLOYEES, OR OTHER REPRESENTATIVES.

4.3 Limitation of Liability

THE MSF AND GSMA DISCLAIM ANY AND ALL LIABILITY RESULTING FROM, OR RELATED TO THE IOT EVENT. EVERY PERSON OR COMPANY PARTICIPATING IN, OR ATTENDING THE IOT EVENT DOES SO AT ITS OWN RISK. THE MSF AND GSMA ASSUME NO LIABILITY WHATSOEVER FOR ANY HARM TO ANY PERSON OR COMPANY, AND FOR ANY DAMAGE, OR LOSS OF ANY EQUIPMENT, DATA, OR ANY OTHER LOSS RELATING TO ANY COMPANY'S BUSINESS RESULTING FROM ANY CAUSE WHATSOEVER RESULTING FROM ANY CAUSE OTHER THAN THE GROSS NEGLIGENCE OR WILLFUL MISCONDUCT OF THE MSF OR GSMA RESULTING IN PERSONAL INJURY TO ANY PERSONS IN PREPARATION FOR, DURING, OR IN CONNECTION WITH THE IOT EVENT.

OTHER THAN AS EXPRESSLY SET FORTH IN THE PRECEDING PARAGRAPH, IN NO EVENT SHALL THE MSF OR GSMA BE RESPONSIBLE OR LIABLE TO ANY PERSON OR COMPANY THAT PARTICIPATES IN OR ATTENDS THE IOT EVENT, OR TO ANY PERSON OR COMPANY THAT PROVIDES SERVICES TO ANY PERSON OR COMPANY THAT PARTICIPATES IN, OR ATTENDS THE IOT EVENT, FOR ANY CLAIMS ARISING OUT OF, OR RELATED TO THIS AGREEMENT, SUCH PERSON OR COMPANY'S BUSINESS, OR OTHERWISE. OTHER THAN AS EXPRESSLY SET FORTH IN THE PRECEDING PARAGRAPH, IN NO EVENT SHALL THE MSF OR GSMA BE RESPONSIBLE OR LIABLE FOR ANY SPECIAL, NON-COMPENSATORY, CONSEQUENTIAL, INDIRECT, INCIDENTAL, STATUTORY OR PUNITIVE DAMAGES OF ANY KIND, INCLUDING, WITHOUT LIMITATION, FOR ANY LOST REVENUES, LOST PROFITS, REPLACEMENT GOODS, LOSS OF TECHNOLOGY, RIGHTS OR SERVICES, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, WHETHER UNDER CONTRACT THEORY, OR TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE.

NEITHER MSF, GSMA, OR ANY OF ITS OFFICERS, DIRECTORS, AGENTS, ADVISORS, EMPLOYEES, OTHER REPRESENTATIVES, OR ASSIGNS SHALL BE HELD LIABLE FOR, AND THEY ARE HEREBY RELEASED FROM, ANY DAMAGE, LOSS, HARM, OR INJURY TO THE PERSON OR PROPERTY OF THE PARTICIPANT OR ANY OF ITS VISITORS, OFFICERS, AGENTS, EMPLOYEES, OR OTHER REPRESENTATIVES, INCLUDING WITHOUT LIMITATION, DAMAGE, LOSS, HARM, OR INJURY RESULTING FROM THEFT, FIRE, EARTHQUAKE, INCLEMENT WEATHER, WATER, UNAVAILABILITY OF THE FACILITIES, INJURY IN CONNECTION WITH THE IOT EVENT, PLANNING MEETINGS, OR STAGINGS, FOR REASONS BEYOND MSF'S CONTROL, ACCIDENT, OR ANY OTHER CAUSE. NOTWITHSTANDING ANYTHING TO THE CONTRARY IN THIS AGREEMENT, THE MAXIMUM AGGREGATE LIABILITY OF MSF OR GSMA TO ANY IOT EVENT PARTICIPANTS, OR THEIR EMPLOYEES, OFFICERS, DIRECTORS OR SUBCONTRACTORS RELATED TO, OR IN CONNECTION WITH THIS AGREEMENT, WILL BE LIMITED TO THE TOTAL AMOUNT OF FEES PAID BY THE IOT EVENT PARTICIPANT TO MSF OR GSMA HEREUNDER IN CONNECTION WITH THE IOT EVENT.

THE LIMITATIONS SET FORTH ABOVE SHALL BE DEEMED TO APPLY TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW AND NOTWITHSTANDING THE FAILURE OF THE ESSENTIAL PURPOSE OF ANY LIMITED REMEDIES. THE PARTIES ACKNOWLEDGE

AND AGREE THAT THEY HAVE FULLY CONSIDERED THE FOREGOING ALLOCATION OF RISK AND FIND IT REASONABLE, AND THAT THE FOREGOING LIMITATIONS ARE AN ESSENTIAL BASIS OF THE BARGAIN UNDERLYING THIS AGREEMENT.

4.4 Insurance

Participant represents and warrants that it maintains and will maintain adequate insurance protection against all liabilities, claims and risks against which may arise in connection with its participation in the IOT Event, and no less than is customary for entities engaged in Participant's line of business. Participant agrees that it shall furnish to the MSF or GSMA, upon request, with a certificate of insurance verifying its compliance with the requirements of this section.

4.5 Relationship

The relationship between the parties is that of independent contractors. The Participant is not an employee, agent, partner or legal representative of the MSF or GSMA and shall have no authority to assume or create obligations on behalf of the MSF, GSMA or the IOT Event. Nothing contained herein shall be construed to imply a joint venture, principal or agent relationship, or other joint relationship, and neither party shall have the right, power or authority to create any obligation, express or implied, on behalf of the other.

4.6 Assignment

Participant shall not assign to a third party its rights, or obligations, or any portion thereof without the prior written consent of MSF and GSMA, which consent the MSF and GSMA may grant or withhold at its sole discretion. Any attempted assignment without such consent by the MSF and GSMA shall be void and of no effect, and shall constitute a material breach by Participant of its obligations hereunder.

4.7 Logistics

Each Participant that provides equipment or services capable of communication may interconnect their equipment or services to other Participants in the IOT Event using protocols and interfaces as agreed upon in the overall IOT Event design established collectively by the Participants. Participant hereby consents to the inter-connection of its equipment or services with other Participants in the IOT Event.

Participants will be responsible for shipping their own equipment and making arrangements with the host for installation. If participants are shipping fully equipped racks or other large/heavy items, they must make special arrangements for handling and provide an adequate number of people for safe installation. Participant is solely responsible for shipping, installing and demonstrating its products or services. Upon the completion of the IOT Event or upon MSF's or GSMA's request, Participant will immediately remove any and all Participant equipment or other property from the site of the IOT Event, and return the site of the IOT Event to the same condition as it was prior to Participant's use of the facilities. Participant agrees that it shall be solely responsible for any damage caused by Participant, its equipment or the IOT Event thereof, and that it shall indemnify, defend, protect and hold harmless, the MSF and GSMA from and against any claims arising out of Participant's failure to do so.

Due to the complexity of and importance to all Participants in the IOT Event, when applicable, the Technical Coordinator reserves the right to have products or services that are causing disruptions in the implementation or operation of the IOT Event temporarily removed from the

IOT Event until the disruption can be corrected. The MSF and GSMA agree, to the extent commercially reasonable, to work cooperatively with those Participants (but at no cost to MSF or GSMA) whose products or services are causing disruptions in the IOT Event's operation so that such Participants can be reconnected to the IOT Event at the earliest possible time. At all times, the first priority of MSF and GSMA will be to keep the majority of the users of the IOT Event up and operational.

Every effort will be made by Host sites to make hotel recommendations near their respective lab sites. However, it is the responsibility of each participant to make their own travel arrangements, hotel accommodations, arrange transportation and their own meals. Participant shall be responsible for all costs and expenses it incurs in connection with the IOT Event and this agreement.

Participants must also conform to the hours of operations (start of testing, breaks and end of testing and any planned days off) according to the VoLTE Event Technical Coordinator and TC Chair. Any change to the schedule proposed by the Participant, shall be subject to review and approval in advance by the VoLTE Event Technical Coordinator and TC Chair.

In the performance of this agreement and in connection with the IOT Event, Participant shall at all times comply with all applicable local, national and international governmental laws, statutes, ordinances, rules, regulations, orders, and other standards or requirements, including without limitation such governmental requirements applicable to environmental protection, health, safety, import or export control, customs, transportation, intellectual property, anti-trust, or any other relevant law of any jurisdiction effected by the Participant's participant in the IOT Event.

Given the multi-vendor nature of the VoLTE Event IOT Event, the Participant is only allowed to administer their own equipment and may not access or administer equipment from other participants, unless given express permission to do so by the other Participant.

4.8 Planning Meetings and Conference Calls

Participant agrees that their contacts or their delegates will fully participate in any planning meetings, conference calls or other activities scheduled by MSF and GSMA in order to plan for and execute the IOT Event.

4.9 Pre-Testing, Staging, and IOT Event Setup/Tear down

Participant agrees to participate in staging events scheduled to ensure the correct functioning of the IOT Event. Participant shall supply technical personnel on-site to aid in the pre-IOT Event staging at the designated staging location and the setup and tear down of equipment and/or services at the IOT Event.

Participant agrees to provide the event Technical Coordinator and their host-site(s) with detailed product information for each piece of participant equipment. Product details should include but are not limited to, make/model number, interfaces supported, size/weight, color, power requirements, rack needs, and etc.

4.10 Scheduled Testing Slots

The VoLTE IOT Event requires careful scheduling well in advance of the event to ensure that each participant is able to complete all desired interoperability testing with all desired partners.

The success of the VoLTE Event is contingent upon the ability of participants and host-sites to closely adhere to the agreed upon schedule. Participant equipment that fails to operate is a serious deterrent to our ability to adhere to the schedule.

Given that all host-sites are open to participants and equipment setup at least on week prior to the VoLTE Event beginning on **Monday September 12 2011**, all participant equipment is required to be operational, configured, and networked prior to 8:00am (local time) on **Monday September 12 2011**. In the event that a participant misses a scheduled testing slot due to equipment failures, the VoLTE Event organizers will make every attempt to reschedule that participant for a new testing slot. However, there is no guarantee that the schedule will allow for a new testing slot.

4.11 Marketing Activities/Media (“Press”) Contact

Participant may advertise, market or promote its products in reference to the VoLTE IOT Event and/or testing activities within the following parameters: a) Participant may describe their equipment deployed during the test event e.g., features, functions, size, power consumption, etc. Under no circumstances can cost or price be mentioned; b) Participant may state that they “successfully participated at the event” and that they “successfully participated in a specific test case (s)”. No single vendor’s specific test results may be mentioned nor should any vendor state that they have “passed” the testing; c) Participant may issue their own press releases, which may contain information on who they are partnering with at the event as long as they obtain express written approval from their partner (s). Participant also may provide individual quotes for their own press releases. Prior to their release, all press releases must be approved by the MSF Marketing Project Manager and GSMA Project Manager. . The MSF and GSMA shall issue press releases for the IOT Event at their own discretion. Participant agrees that press releases issued by the MSF and GSMA may indicate Participant participated in the IOT Event. Any press releases issued by Participant in reference to the VoLTE Event will follow guidelines specified by MSF and GSMA. Participants agree to be listed in all materials related to the event including press releases and collateral without specific notification.

4.12 Cancellation or Termination of Exhibition

If, because of war, fire, strike, earthquake, power shortage, construction, inclement weather, shortage of materials, government regulation, public catastrophe, Acts of God or public enemies, or any other cause beyond the control of the MSF, GSMA, the IOT Event, or any part thereof is prevented from being held, is canceled by MSF and GSMA or the space for the IOT Event becomes unavailable, the MSF and GSMA in their discretion, shall reasonably determine and refund to the Participant the balance of the aggregate Participation fees received which remains after deducting expenses incurred by the MSF and GSMA and reasonable compensation to the MSF and GSMA. The MSF and GSMA shall have the right to terminate this agreement for any reason (or no reason) upon fifteen (15) days prior notice to Participant, and in such case will refund fees to the extent described in the preceding sentence. In no case shall the amount of refund to Participants exceed the amount of the Participation fee paid.

4.13 Participant Cancellation (Fees and Penalties)

Cancellation of any portion of the Application by the Participant will be accepted only in writing and at the of MSF and GSMA. In the event of any cancellation by Participant after **June 30 2011** no participation fees will be refunded.

4.14 Photography

No photographs or videotapes shall be taken or made without the prior written consent of the MSF Technical Chair or GSMA Project Manager.

4.15 Agreement to Terms, Conditions and Rules

Participant agrees to observe and abide by the foregoing terms, conditions, and rules, and by such additional terms, conditions, and rules made by MSF and GSMA from time to time for the efficient and safe operation of the VoLTE IOT Event, including but not limited to, those contained in this Agreement. In addition to MSF's and GSMA's right to withdraw its acceptance of the Application, MSF and GSMA in their judgment may refuse to consider for participation in future IOT Events any Participant who violates or fails to abide by all such terms, conditions, and rules.

If any provision of this agreement is held by a court of law to be illegal, invalid or unenforceable, (i) that provision shall be deemed amended to achieve as nearly as possible the same economic effect as the original provision, and (ii) the legality, validity and enforceability of the remaining provisions of this agreement shall not be affected or impaired thereby. This agreement will be governed by the laws of the State of California without reference to its conflict of laws principles. This agreement constitutes the entire agreement with respect to the subject matter set-forth herein, and supersedes all prior or contemporaneous oral or written agreements concerning such subject matter. The parties acknowledge that the NDA governs confidential information disclosed in conjunction with the IOT Event. This agreement may be amended or modified only by mutual agreement of authorized representatives of the parties in writing.

Each of the parties irrevocably consents to the exclusive personal jurisdiction of the federal and state courts located in Alameda, California, as applicable, for any matter arising out of or relating to this Agreement, except that in actions seeking to enforce any order or any judgment of such federal or state courts located in California, such personal jurisdiction shall be nonexclusive.

If any dispute arises between the parties with respect to the matters covered by this Agreement which leads to a proceeding to resolve such dispute, the prevailing party in such proceeding shall be entitled to receive such prevailing party's reasonable attorneys' fees, expert witness fees and out-of-pocket costs incurred in connection with such proceeding, in addition to any other relief to which such prevailing party may be entitled.

The headings used in this Agreement are for organizational purposes only and are not to be used in the interpretation of the substance of this Agreement.

6. Technical Information

The VoLTE Event will take place simultaneously in Europe and Asia. The MSF and GSMA understand that the decision to participate in a VoLTE event can be complex.
